YSC MISSION

To engage in juvenile justice planning and priority-setting in developing new community programming for juveniles and monitoring the effectiveness of existing programs in the community for at-risk youth and youth offenders that assist clients in becoming independent, healthy, and safe.

YSC GOALS

- Better outcomes for clients and communities through collaboration, integration and shared responsibility.
- Reduce delinquency and antisocial behaviors resulting in youth incarceration and recidivism.

JUVENILE JUSTICE COMMISSION

POINTS OF INTERVENTION DEFINITIONS

Each of the programs in the Union County Youth Services Commission Continuum of Care has a specific goal.

PREVENTION: To prevent youth from engaging in anti-social and delinquent behavior and from taking part in other problem behaviors that are pathways to delinquency.

DIVERSION: To provide services and/or informal sanctions to youth who have begun to engage in anti-social and low level delinquent behavior in an effort to prevent youth from continuing on a delinquent pathway.

DETENTION/DETENTION ALTERNATIVE: To ensure youth's presence at court hearings and to provide short term (45-60 days) supervision sufficient to safely maintain appropriate youth in the community while awaiting the final disposition of their case.

DISPOSITION: To provide the court with a range of options that match the supervision and service needs of youth in their communities in an effort to reduce recidivism.

REENTRY: To provide youth transitioning from JJC residential programs and youth returning from secure facilities with additional support for successful reintegration into their communities in an effort to reduce recidivism.

Service Description: The Institute of Music for Children’s Afterschool and Summer programs will provide Union County pre-teens and teens, ages 8-18, with delinquency prevention services including: instruction in performing arts (voice, drama, dance, spoken word), instrumental music (guitar, drums, piano, harp violin, cello), and/or multi-media (electric music or video production), with a focus on sustained motivation, regular attendance, at-home practice, and public performance.

Service Description: Using fun activities and interactive group methods, youth and their mentors engage to ensure mentoring does not occur by chance. This program is a comprehensive youth development initiative with individual, group, and peer mentoring occasionally involving parent participation with a connection to any needed family resources. Role models are integrated into the process to help youth focus on their future (careers and lifestyles). By using evidence based curriculums, youth have the opportunity to improve social behaviors, individual differences in thinking, reasoning, decision making and their self-esteem. Additionally, youth are provided tools for team building using group activities to assist in their positive development. The sessions are, at a minimum, one hour per week, year-round, with a minimum of 26 weeks of participation required in a calendar year to complete the program.

Service Description: The Family Crisis Intervention Unit (FCIU) is a legislatively mandated program for families experiencing family conflict, runaway behavior, truancy, minor delinquency, a threat to safety issues, and human trafficking within the family unit warranting intervention. The goal is to mediate the immediate crisis and make recommendations to prevent involvement or further involvement with the court. When all appropriate resources are exhausted, and the family is still in crisis, FCIU has the option of filing a Family Crisis Petition with Family Court. This program has 24/7 response capability.

The Union County Dept. of Corrections Juvenile Detention Bureau Electronic Monitoring Program is utilized as an alternative to secure detention upon release, while awaiting disposition to assist in sustaining Union County's continuing participation in New Jersey's Juvenile Detention Alternative Initiative (JDAI). Thirty-five (35) youth are to be served in this program annually. Union County Dept. of Corrections Juvenile Detention Bureau will install and remove the Electronic Monitoring (EM) units as well as provide initial intake.

Service Description: This program is a court ordered alternative to secure detention. The primary goal is to prevent detention overcrowding by permitting low risk offenders to be monitored at home while awaiting final court disposition of their case. Youth are monitored 24/7 via a GPS tracking system for compliance with home confinement and other court ordered conditions of release. Program provides linkages to resources as needed.

Service Description: A six to nine month program that provides co-occurring mental health and substance abuse treatment for court-involved youth and their families. Services at Trinitas Regional Medical Center provide development of positive coping skills; identification of relapse triggers; individual and family therapy; group therapy; medication management (if applicable); relapse prevention; random drug screens; and regular monitoring. The treatment utilizes an emotionally therapeutic and empathy building approach while emphasizing the development of emotional intelligence and healthy personal empowerment for youth and their families. Our clinical team collaborates with other support agencies that may be involved in their life such as their school, physician, case management, probation officer, parole officer, in order to create a strong and efficient support system.

Service Description: Trinitas Regional Medical Center's Outpatient Early Intervention and Sexual Offender Program provides trauma-sensitive cognitive behavior therapy and sexual offender specific treatment services to at-risk youth who are not involved in the juvenile justice system, court-ordered youth charged with sexual offending behaviors and reentry youth who are returning from JJC residential/secure facility who are referred by Probation and/or Parole. Programming includes individual, group, and family therapy; Union County S.H.A.R.E (Sexual Harassment and Regaining Empowerment) Program for youth ages 11-18 who are either a victim of a cyber sexting crime or those who have committed a cyber sexting crime.

Target Population: Youth between the ages of 13- 21 years old with sexual behaviors and/or sexually abusive behaviors who have been court ordered or serving a term of probation in the disposition category or youth returning from a Juvenile Justice Commission secure and/or residential facility in the re-entry category; youth not court involved who are displaying early signs of inappropriate sexual behavior between the ages of 8-13 years old.
